

MOBILE APP RESERVATION AGREEMENT

TO: Technical Consultants and Experts Group Inc. ("TCE")

1. Commitment \_\_\_\_\_ ("Pharmacy"), offers to subscribe from TCE a customized Mobile App called MypharmacyApp developed by TCE, to provide easy and secure way for the Pharmacy's customers ("Customers") to: place orders for their medications (prescription fills & refills) from a remote location and generally to enable Customers to place orders 24/7 and after hours and to avoid line-ups at the dispensary counter. It is understood the monthly subscription fee includes the ongoing maintenance of the App, the customer's usage and minimum 30 customers' transactions per calendar month.

3. Term The Pharmacy and its customers will have access of the Mobile App for the period starting with the installation of the App and ending in (minimum 1 year)\_\_\_\_\_.

4. Delivery The Mobile App to be installed on or before\_\_\_\_\_

5. Additional Services In addition to the basic services contemplated in paragraph 1, the Pharmacy also wishes to acquire those additional services checked off below at your standard rates for those services:

- (a)  Customization (of the interfaces and/or back end integration)
- (b)  Customization of the Mobile App features
- (c)  Integration with in-store Kiosk

6. Fees TCE's subscription fee for making the Mobile App available and for the provision of the basic services will be \$\_\_\_\_\_ per month per pharmacy location. Additional transaction fee of \$0.5 will be charged for each transaction/order (New prescription or Refill order) is processed by the Mobile App above the minimum 30 customer's transition per Calendar month

7. Deposit Contemporaneously with the delivery of this Reservation Agreement the Pharmacy will deliver to TCE a negotiable cheque payable to TCE in the amount of:

- (a) \$ 250.0 (the "Setup Fee") for setting up the Mobile App for the pharmacy customers.
- (b) \$ \_\_\_\_\_ (the "Security Deposit") as a payment for reserving the Mobile App and generally as security for the performance of the Pharmacy's obligations hereunder; any part of the Security Deposit not used will be returned to the Pharmacy within 60 days of the end of the term.

If this Reservation Agreement is not accepted by TCE, the Setup fee and the Security Deposit will be promptly returned to the Pharmacy without interest or deduction.

8. Assignment and Subletting The Pharmacy cannot assign this agreement.

9. Agreement If TCE signs back this Reservation Agreement, the Pharmacy will execute and deliver TCE's standard form of Agreement (the "Agreement") for the use of the App but

completed in accordance with this Reservation Agreement, and with only such other amendments as may be agreed to by both the Pharmacy and TCE, as soon as practical following the live launch of same. If the Pharmacy has not executed and re-delivered the Agreement to TCE within thirty (30) business days after receiving it, TCE may at its option, by written notice to the Pharmacy, terminate the agreement arising out of this Reservation Agreement and TCE's acceptance and may retain the Setup Fee and the Security Deposits, without prejudice to any other rights or remedies which TCE may have by reason of such default by the Pharmacy.

10. No Representations and Merger There are no covenants, representations, agreements, warranties or conditions in any way relating to the subject matter of this Reservation Agreement, whether express or implied, collateral or otherwise, except those specifically set forth in this Reservation Agreement and in the final Agreement. The covenants, representations, agreements, warranties and conditions contained in this Reservation Agreement, will merge with Final Agreement when it is executed by the parties. TCE is not to be considered to have made an Offer to the Pharmacy by preparing this Reservation Agreement.
11. Governing Law, etc. This Reservation Agreement is governed by and construed in accordance with the laws of the Province of Ontario and the laws of Canada applicable therein. The parties attorn to the jurisdiction of the Courts of Ontario. This Reservation Agreement enures to the benefit of and is binding upon the parties and their respective heirs, executors, administrators, successors and permitted assigns; provided however that this Reservation Agreement may not be assigned or transferred by the Pharmacy without the prior written consent of TCE.
